WORDS FROM NEW JERSEY

Since the last newsletter, we received the sorrowful news that Keith Nolan has passed away. Those who fought in Ripcord will always owe Keith a debt of gratitude for his able telling of our story to the rest of the world. The efforts of Chip Collins and Keith Nolan have kept the story of the sacrifices and hardships endured by the 101st alive for all to recognize. They and others who have died before them will be greatly missed by their friends, family and brothers in arms.

On a lighter note, Kathy and I had a great time at the Laughlin, NV reunion in October! We left on October 2 and arrived on the 6th. With the able help of the Bob and Red Judd and Fred Spaulding, we loaded up the smaller than usual hospitality room with snacks, beer, soda, water and liquor in anticipation of the 100 plus friends attending the reunion.

Some people had been there since Saturday and as the week progressed just about all came in so that by Friday we had a full house.

Between the casino games on the bottom two floors and all the things to see and do in the area it was hard to meet with everyone for more than just a few minutes. While it was tough to get together with everyone during the week, all seemed to have a really good time. It appeared that most of those attending donated a fair amount of money to the Nevada State coffers.

At the business meeting a couple of things were decided:

1. We must always be certain the hospitality room is large enough for our group.
2. The association will spend about \$100 for memorial wreaths for those who pass away while we can afford it.
3. A raffle will be held each year for the benefit of the Anna Britt Nolan Trust Fund.

4. In the next 3 or 4 years we will try to start holding our reunion in one semi-central location for an extended period. (possibly Springfield, MO) to reduce costs and ensure the gear for the reunion will always be there. This will require purchase of an enclosed trailer (5'x 8') and rental of a storage place close to the selected location.
5. It was voted to give the Judds and the Widjeskogs \$300 each for gas expenses for hauling all the gear to Laughlin.
6. Reunions are set for 2009 in Myrtle Beach, SC and 2010 in Springfield, MO. It is also likely that we will be in Fort Worth, TX in 2011.

The report by the treasurer was as follows:

We ended the Springfield (2007) reunion with a balance of \$18,640. From the end of the Springfield event to end of the Laughlin reunion we have accumulated the following expenses and received income as listed below.

Expenses: Newsletter, postage, website since Springfield was \$ 1,360.26

Income: Donations and book sales: \$5,624

Laughlin Reunion expenses: \$7,832

Laughlin Registration fees: \$ 8,030

Laughlin Raffles & sales: \$3,028

Anna Britt Trust raffle & donations: \$1,600

Giving the Association a **balance** of \$27,730 in the account at the end of the Laughlin reunion.

Overall, the association is doing well financially for the present time and our expenses are being met.


- The above rates of \$75.00 per night do not include state & local taxes or applicable hospitality and resort charges of 18.25% per night.
- Maximum permitted occupancies for each unit is determined by Sands Ocean Club Resort. Rates are based on two (2) adults per bedroom. Additional adults (18 & over) add \$18.00 per person, per night.
- An access charge of \$2.14 per night is applied to all guest folios and includes free local calls, as well as toll free 800 numbers and unlimited use of the in-room personal safe.
- Cancellation of individual room reservations up to 96 hours prior to arrival is subject to a \$50.00 processing fee. Cancellation of individual room reservations within 96 hours prior to arrival date is subject to loss of the first nights deposit.

KEITH NOLAN

Frank e-mailed us today, letting us know the upcoming *Ripcord* newsletter would be a tribute to Keith Nolan. He asked if we would like to write something. Of course we would . . . and if you've checked out the link to the on-line memorial book for Keith, you will find there are many others who want to write about Keith and express their gratitude for all he has done for Vietnam vets by telling their stories.

Like so many others, Keith found us—or, I should say, George—by way of writing *Ripcord*. My husband had never spoken much about his tour of duty in 'Nam. In the early years of our marriage, it was something we didn't talk about because I felt it was a subject not to be discussed and therefore I didn't pursue it. Let sleeping dogs lie, I thought to myself, but the sleeping dogs weren't lying. In retrospect, like so many other Vietnam vets, my husband had unresolved issues from his days in the service. After we became a part of *Ripcord*, my husband became a different man—more open and communicative, and at last willing to talk about the war . . . and I have Keith Nolan to thank for that.

Despite not having met Keith in person, I was impressed with the way the guys at the *Ripcord* Association had such high regard for him. I kept thinking that this guy has really brought a lot of lost souls and broken spirits together . . . and they are healing and becoming a real family—all because he told their story. This has been affirmed over and over again at each subsequent reunion.

Then in January of 2008, we learned the news of Keith's terminal cancer through the *Ripcord* website. Not long after, my husband said to me, "I want to do something—I want to see about starting a college fund for Keith's daughter." He contacted Lee and was told that he wasn't the first to come up with the idea; however, the Association needed someone who was willing to put the idea into action. My husband immediately went to our local bank for information and we consulted an attorney who specializes in trusts. We then e-mailed Keith and he promptly

replied, telling us how happy he was that his friends at *Ripcord* were willing to do this for his daughter and how it comforted him to think she might have the opportunity to get a college education. Unfortunately, Keith's health declined and months went by with no communication. We kept e-mailing and then started sending letters, hoping if Keith wasn't able to read them, someone close to him might . . . and one evening the phone rang and it was Keith's mother. She explained that Keith was quite ill due to the chemotherapy treatments and was unable to do much of anything, so she would work with us. After that things fell in order and the trust fund was established.

During this time, we became friends with Keith's family, and then Keith invited us to come for a visit in November. We had a wonderful visit and I was instantly impressed by his attitude. Here was a man who, despite facing death in the near future, had such a great outlook on life. He told us about writing his books and how he got started—hanging out around Viet Nam veterans at the college where his father was a professor. He spoke about Britt and how much he loved being her father and how much he would miss seeing her grow up. He told us about wanting to write his life's story to her in the form of a letter and he was just hoping he could finish that goal. He said the *Ripcord* veterans were by a great group of people to work

with on his book. His mother was so full of pride over Keith's accomplishments. She was so thrilled he was still with her, but so aware he was deteriorating.

We were saddened when she called the evening of February 19th and said he had passed away. We had hoped arrangements would be made for a memorial service, but after a year of struggling with Keith's illness, we were told the family is just not ready to do anything at this time. However, on short notice, Keith's former wife planned a memorial mass at a small church in the area they had resided. We felt a need to go and give our condolences to Keith's family. At the church, Ulla Nolan, Keith's mother, came up and thanked us for coming. Afterward, there was a luncheon at a church hall down the road. There we spoke with family and friends of Keith and we had a chance to meet Britt, his daughter. She is cute as a button and seemed to be handling everything quite well. Keith's ex-wife, Kelly, seemed intent to make it a pleasant experience for Britt and Keith's family. After the luncheon, she asked everyone to come up and give an anecdote about Keith and light a candle. Various friends and acquaintances spoke of their favorite memories of Keith, and George went up and told of Keith writing *Ripcord* and how his books have meant so much to veterans. After that, Tony DeLuca introduced himself. He had come from Philadelphia and said he was in the Big Red 1 during Tet in Saigon and Keith had written about that in his book, *House to House*. Afterward, he visited with us and told us he had never met Keith personally, but had spoken with him on the phone. Like us, he felt a need to come. He had learned about the mass from reading about it on the *Ripcord* website. A little later, Bill McClellan, a reporter from the St. Louis Post-Dispatch, came over and introduced himself. He was there to give his respects to Keith's family. He told us how much he enjoyed his interviews with Keith and found Keith's books so interesting.

Keith's mother and brother Erik asked us to extend their warm wishes to everyone at *Ripcord*, and to thank everyone for all of their generosity, concern and prayers during this difficult time. We will continue to stay in touch with them.

And, finally – Keith, you were called to rest too soon. You did so much for so many in the short life you had – and you will never be forgotten.

TRUST FUND FOR KEITH NOLAN'S DAUGHTER

For those who have missed the sad news, earlier this year Keith Nolan, the author of "Ripcord, Screaming Eagles Under Siege", and friend to many of the *Ripcord* survivors, has been diagnosed with fourth stage lung cancer. My name is Steve Cooper. I was drafted in September of 1969. Did Basic at Ft. Leonard Wood and AIT at Fort Ord. I arrived in Vietnam on March 10, 1970, and returned home May 14, 1971. I arrived in Vietnam with a 11B mos but was pulled to work at Division HQ when I arrived at the 101st. I worked in the Casualty Branch of the the Division at Phu Bai and was givien the job of casualty reporting and letters of sympathy. Guess I ended up being a REMF but dealt with the tradegies of the war daily. A few years ago I bought Nolan's book and talked with him on the phone. For some reason I only got about half way throught it until just recently when I picked it up again and finished it. Much of the Ripcord battle and others of 1970 and early 1971 are still in my memory. Yesterday, Feb 3, 2009 I boarded a flight from Fairbanks to Anchorage. I was on my way to see the "Great Oz" aka the VA. As I boarded I noticed an Iraq Vet in a seat in front of mine. As I passed him we locked eyes and nodded. When I was seated I got up and went back up to him and thanked him for his service and mentioned I was on the way to the VA for repairs. After taking my seat I noticed him retrieving his back pack then he got up and came back to me. He then took my hand and shook it saying "Welcome Home" and something about we were never treated right. As he was shaking my hand he "coined" me with a spectacular medallion! He was a 1st Sergeant Medic with the 101st. The coin is gold with royal blue boarder that reads on one side "USA MEDDAC ALASKA" & "ARCTIC MEDIC" with a bear and mountains engraved. The other side has a black ring with "ARMY STRONG" & "ABOVE ALL WE CARE". The center of the coin is Royal Blue back-ground and had the stars of the Big Dipper and Colonel's

insignia along with the 1st Sergeant strips then a serial number. I nearly lost it as I was already in an emotional unstable state due to my trip for a C & P exam. This was a gesture that I was very unfamiliar with. Over the years I have grown accustom to being ignored all together or shunned as if I were a leper. I thought that you might like to know that the present Screaming Eagles are still wearing the patch with much pride and a lot of class.
