

I would appreciate any information on Tom Shriner. I have really been enjoying your site and learning a lot of the happenings around Tom's time there. It was rather ironic, I didn't even know he was in the service until I returned home on leave and found that we were both going to Viet Nam. I had just missed him and ended up he went and my orders were flagged and I went to Ft Bragg, NC. I got there in Dec 1969 and learned of Tom's death at the end of April 1970.

I remained with the service after my discharge by joining the National Guard and then after a couple breaks went into the Army Reserves, was mobilized 2005 to 2007 to Ft Hauchuca AZ and retired out of Reserves with 35 years, 2 months, 3 days on 1 Feb 2009...

Any members who served with Tom please contact me as I would like to know how he became a KIA. I learned of Tom's death well after he was buried as I was also in the Service at that time but the family became anti- military after his death and would not talk about it. When trying to sling load a dozer onto a bare Ripcord LZ with my Ch-47 Chinook (call sign "Varsity"), I darn near took a hit from mortars on a very short final approach. I flared out and barley made it over the LZ. I took the dozer back to Camp Evans. While awaiting further orders I was released for other work. This may have been the 1 April 1970 failed assault. Maybe the Pathfinders will recall this.

We also pulled off a really neat extraction of Pathfinders who were trapped in the clouds across the valley south of Ripcord. A call came over our UHF emergency frequency calling for volunteers. We were heading south with no load and responded. The Cobra escort and Hueys could not make it into the valley due to the weather. But we were able to locate the Pathfinders on the log strewn LZ by hovering up the mountain side. Our crew pulled them aboard with their nylon straps. We did an instrument take off straight up and made radar contact for a vector and GCA approach at Phu Bia airfield.

The Pathfinders had their HQ next to our "Varsity" area at Camp Eagle. They bought drinks that evening at our club. I wonder if any of them remember this. I believe they were scouting for an LZ when they got trapped in the clouds. Maybe this was hill 906? This happened after 1 April but before 13 April when my Chinook took a direct 210 mm mortar round hit on a short final to FSB fuller. Four out of the crew of five survived the crash onto the firebase loading pad. That ended my combat flying career.

God bless all the Ripcord vets.

On an LZ mission with 3rd platoon, we were attacked on 18 Feb suffering 2 KIA and 5 WIA all members of 3rd platoon. All of us LZ Cutters became members of 3rd platoon after that. I stayed with the company through March and April and then was awarded a rear job in supply on 14 April. Was on Ripcord the final three days 21-23 July. Ended my tour logging supply birds to all the companies from my home on FSB Rakkasan.

Days after the evacuation of FSB ripcord, I was on the first Bird into the saddle where Captain Don Workman was killed to retrieve the bodies left behind. I am the one who discovered his body. B Co. 2nd/501 located all of the deceased soldiers. I learned from SGT. Melvin Olsen in 2013 that one of the bodies we found died in the kneeling position, on his (hands and knees). We were told that the LZ had been gassed and would be HOT so we had gas masks on. I disembarked the slick and ran out of the right side of the bird, with Don Otto and LT. Robert Layton.

I ran to a fallen tree and hit the deck. As I waited for the reception by the NVA. As I looked over the log with my gas mask still on, I focused on a 1/2 of a human being, the upper torso, and a black skeleton. I saw the Captain Bars on the collar, and the eye sockets where red beetles were crawling. I then moved out waiting for

the reception committee to greet us, they had left. I ran to the base of a hill and took off my gas mask. I looked up and there had to be 15 to 20 helicopters peppering the ridge above us. I thought to myself what the hell happened here. Too, I thought it sure is a beautiful day today. I think it was somewhere around the end of July.

Brother Lee,

I am Stephen Forsstrom; I was a platoon leader on 19 April 1970 when I lost two soldiers during an early morning assault by the NVA. Personally, it was a tragic loss as I felt these two deaths were avoidable; I was compelled to set my platoon in a NDP that I felt was placing my element in extreme vulnerability. I petitioned the company commander, Captain Robert Stanton, to permit me to move my platoon away from the bottom of a hill. I requested one other platoon leader to accompany me for a second request, to no avail. The next morning, we received RPG fire, as I had prophesized.

I only had Sgt. James Jarrett for about a week when he was KIA. He had received his E5 rank via the NCO school; yet, he was well qualified in holding that rank. As was the case for every one of my NCOs, I would have them accompany me for about a week as I felt it pertinent to train each NCO to be my replacement should

I be dispatched or reassigned. Sgt. Jarrett had a sound aptitude and was destined to take over one of my squads very soon. As I recall, he had just been married shortly before his deployment. My regret is I didn't know him better. The morning he was KIA, he passed immediately from severe wounds to his face and upper torso.

As regards to Sgt. Jeffrey Joseph, he was one of the finest soldiers I've ever served with. Sgt. Joseph made his stripes the conventional way, he earned them through his leadership skills and his astute soldiering skills. He was, indeed, a profound inspiration to our platoon; and, his loss haunted me for years due the circumstances of his death.

When I first acquired the platoon (@FSB Bastogne), near the end of February 1970, 2/B/501 had been without their platoon leader for a few days. The previous platoon leader had transferred to Special Forces soon after he joined them. He had been an effective leader; and, who shoes were a challenge to fill. Nevertheless, 2nd platoon accepted me with some reservation; it was obvious. Soon, we were in the field and almost immediately, we faced some difficulties. It was imperative we attain high ground for a NDP; members of the platoon stated they

were too tired to continue and wished to set up where we were. I stated we were going to high ground, on the horizon; and, in spite of my 90# ruck, I went & grab a MG's "pig", threw it over my shoulder, and ordered them to follow me. I had taken about a dozen steps when I heard Sgt. Joseph command (the platoon) with, "... you heard the LT; get moving". There was another instance whereby Sgt. Joseph was a inspiring, it was a much appreciated action.

Sgt Joseph had a unique sense of humor. My first night in the jungle, thanks to a scout dog, a cobra was discovered in my intended platoon CP. After much trepidation, I dispatched the snake w/ a point man's machete. Immediately, Sgt Joseph asked for the skin to make a hat band! He had grown up in a rural area of California and was into outdoor activities. Hunting NVA wasn't much different than hunting wild game, in his view. He was a focused leader; yet, there were times when he could be a kid.

Sgt Joseph commenced BCT @ Ft Lewis with his brother, Jerry. At the transition to AIT, his brother was sent home due to medical issues. They were close growing up, Jerry was the older, and it bothered Sgt Joseph that his brother couldn't be deployed with him. The family was close; and, it's my understanding his passing devastated the father. His brother, whom I have been in contact with, went through a period of guilt. It was a tragic loss to the family.

On the morning of 10 April 1970, my platoon descended Re-Up Hill, conducting a RIF to the SE towards "the valley". I was walking 4th man and as we arrived onto a relatively flat area, we discerned an ambush directly ahead. My slack man and I, both color blind, yelled 'tiger' while quick-releasing our rucks. We initiated fire on the enemy; they returned fire and departed. As the 5 of us lay within the kill zone, I asked if everyone was ok. We were! However, I began receiving reports of WIAs up the hill. Sgt Joseph was among the five that I medivaced within the hour. Sgt Joseph was assigned to 85th medical in in Phu Bai with a forearm wound.

Following continual direct contact for (12) straight days, and with the loss of personnel due to re-up opportunities (hence, the name of that frightful hill) & casualties, some rear echelon personnel were directed to grab weapons and await a transfer to our

company position. Sgt Joseph somehow heard about the reinforcing while visiting from the medical facility. As was his nature, he wanted to contribute to our need for pack strength. He joined the first sergeant and arrived at our position; that was late in the day of 18 April 1970. He was KIA the following morning.

Sgt Joseph was wounded in the face. As he lay there, my medic discerned he had a pulse and with the assistance from the 1st platoon medic (doc Joh Marks), a trach was performed to enable his breathing; all the while, his head lay in my lap. As his pulse improved, I requested my medic (Jay Eilers) to ride up the penetrator to keep the trach tube from binding; he did so without hesitation. As we moved to an extraction point, we learned Sgt Joseph had passed.
