Unveiling of a NEW DIORAMA Fire Support Base Ripcord

South Vietnam, 1970

Saturday- March 28, 2020 10 AM-4 PM

SC Confederate Relic Room and Military

Museum-301 Gervais Street

In the spring and summer, 1970 the 101st ABN was engaged in a savage campaign with NVA forces on the eastern edge of the A Shua Valley. FSB Ripcord was established on a mountain with the plan to interdict NVA supplies and troops into South Vietnam. The base came under a month-long barrage of enemy mortar and automatic weapons in July until it was evacuated on 23 July. There were more than 143 KIA and several hundred WIA, but the American public did not hear this story.

Find out more, meet Ripcord veterans and learn how the Wildcat chapter of the Armor Modeling and Preservation Society designed and built a new detailed model of Ripcord. This diorama is an early introduction to the upcoming Vietnam exhibition that will open at the CRR in September 2020.

Remembering Bob Zoller 1st Platoon, Charlie Company, 2/506 Infantry, 101st Airborne Div.

On an early May morning in 1970, Bob Zoller and a handful of Charlie Company new guys were put to work to build a bunker on Firebase Ripcord's southern perimeter. Bob, I, and the others were shown where



to dig. We took turns with the picks and the shovels. In between the picking and shoveling, we watched the Army's Cobra gunships use its mini-guns and rockets to strike North Vietnamese Army—NVA--targets on a distant ridge.

About four feet down into the digging, we came across a large boulder. It was at least three feet in diameter. Bob and I took turns on the pick, trying to break it up. Captain Vasquez, Charlie Company's CO, happened by and took an interest in our efforts. After watching our lack of progress, he couldn't take it anymore, so he jumped down into the hole. Grabbing the pick out of my hands, he asked, "What're you? Some kinda city boy?" The Captain showed us how to swing a pick to break up an obstinate boulder. After the demonstration, Bob and I destroyed that rock.

On a sunny, very hot and humid 13 May 1970, Charlie Company left Firebase Ripcord in helicopters for a jungle landing zone. Bob was one of first platoon's M-60 Machine-Gunners.

Bob Zoller was a quiet, intelligent, compassionate, and generous young man with an ironic sense of humor. From him, I was introduced to the literature of J.R.R. Tolkien and its parody, Bored of the Rings. The various books and our discussion of them on the jungle trails and in the night defensive positions helped us to pass the time and to expand the mind.

On 6 June 1970, Charlie Company returned to Camp Evans, for a stand down period of rest and relaxation. Later that day, Bob shared out a care package that he had received from his folks back home in Ohio. It was the first time I'd ever seen or tasted a banana chip. I liked them so much that Bob souvenired me a big handful of them.

The next day, I began a three-week hospital stay in Phu Bai and Can Ranh Bay for surgeries on my leg and convalescence for a severe jungle-rot infection, known as cellulitis.

On my return to Camp Evans on July first, the Charlie Company clerk told me I was going out to the Company's night defensive position on Hill 902 the next day.

While in the hospital, I had read a couple books that I wanted to talk about to Bob. I was looking forward to seeing him on Hill 902, so we could resume the conversation.

In the early morning hours of 2 July 1970, eight members of Charlie Company, including Bob Zoller, were killed in a battle with NVA sappers and infantry on Hill 902.

It's been almost fifty years since I've seen Bob Zoller, and I still miss him. When I see banana chips at the grocery, I always think of him.

I was very happy to get your correspondence dated 1/14/2020. I was not involved in Ripcord. I was in A 2/506 from 8/69 and was wounded in an ambush on 2/23/1970. The little S.O.Bs shot my thumb off which they reattached in Japan. Memory fails but I think I was in 1st platoon and as far as afterward I was in Ft. Carson. I think the decal you sent was very cool and from everything I heard and read Ripcord was a sob. Congrats on getting back to the world and hope you have a great reunion. I wish I remembered my platoon leader's name because he saved my ass by rocking a M60 and enabling me to crawl back and eventually medavac'd. Thank you for contacting me.

INCOMING MAIL



Lee,

I was the senior company medic with Alpha 3/187 till May of 70. Then I was with the 2/506 as the Senior Battalion Medical Assistant to Dr. Harris. I spent some time with Alpha 2/506 when they were on FSB O'Reily flying in on 1 July then leaving about 10 July. I flew to Evans to conduct sick call. However, I was back to Ripcord the day after the Chinook crashed onto the 105's. Since the aid station on Ripcord was burned out, I had to bring out fresh medical supplies and help out with the increasing number of wounded. I then left Ripcord on 22 July. I was working at 326 Medevac treating all the wounded that were brought in from the evacuation of Ripcord and Alpha 2/506.

Following Vietnam I returned to college and became a physician's assistant. Then attended LSU, New Orleans by way of a scholarship, did anesthesia training in San Diego and completed schooling at Stanford with a Neuro surgical Anesthesia Fellowship from Mayo clinic. I am still working at 73 in Roanoke, VA.

Looking forward to seeing al at Springfield in July. *Jim Crawford*

Dear Sir,

I apologize for the tardiness of my response to your letter re: Victor. I misplaced your letter and kind of forgot about it. No, I was not acquainted with him personally. My only knowledge of him is what I learned from Keith Nolan and official records. Victor and I were the same age,



had the same birth month and had been in that place for about the same amount of time, he was in Company B and I in Company D.

My only personal interaction with him was on the Ripcord Firebase. What I believe to be my first encounter with Victor was when he was one of three soldiers from Company B that took over my 'hole' on the firebase when Capt. Rollison volunteered us to go after Hill 1000. I showed them where the claymores, hand grenades etc. were located upon my exit from that bunker. That was probably on July 6, 1970. The morning of July 10, we returned to the firebase and

while standing around the top of the hill, mortars began falling. You may recall that a bunker for guests had been constructed around the SW (?) corner of the top plateau. That bunker filled quickly with people and room soon ran out. Some of us remained out in the open with nowhere to go. Previously, I had been in the same situation with a fellow named Ron Virgilio and we ran into what turned out to be the ammunition bunker. At that time I said to Ron, let's get out of here because if a mortar blows up in the doorway it might ignite the whole place, we will be blown to bits and nobody will ever know what happened to us. This time I said to 3 others (Mike Sablosky, Michael Walker and?) let's try the bunker that was used to serve hot chow down on the lower level. Four of us scurried off and found the bunker unoccupied with plenty of room.

We stood near the front doorway bullshitting waiting for the mortars to die down. After sometime I ran back toward the top of the hill to see what was planned next when another mortar hit the top near the TOC. I ran back down to the chow bunker and we all waited. During that wait, I was standing closest to the front door when a fellow came running in. A coffee urn was sitting on the countertop and the guy got a couple cups of coffee. He turned to leave and I thought I recognized him as one of the guys that took over my hole on the firebase. I moved out of his way so he could leave the bunker, he was in the doorway when an explosion threw us all across the bunker against the back wall. When I was in the aid station, I heard Capt. Rollison say it looked like the guy took a direct hit. Until Keith Nolan wrote the Ripcord book I wondered everyday who that guy was that saved the rest of us. I firmly believe that at the split second Victor filled that doorway with his body he shielded the rest of us from the bulk of the shrapnel. Sablosky, Walker and I all received multiple shrapnel wounds and I was sent home from my wounds. I forget who else was in that bunker with us but if not for Victor we all would have died that day. I do think about that whole sequence everyday and how just as easily you could be inquiring about me instead of Victor.

That's about all that I can tell you about my experience with Victor Defoor.

I don't know you or ifl ever saw you around in those Vietnam days (11/24/69 to 07/ 10/70) but I remember a nice fellow I met in the hospital that had been a radio operator in Company A. I think of you when I ride Route 55 on the way to New Jersey shore.
